- 2).Issue of Nomination forms(on request in writing) : **19/2/2018 to 21/2/2018** between 3 P.M to 5 p.m. from the office of Election Officer (Assn.Office)
  
3. Last date of submission of Nomination forms : **22/2/2018** up to 6 P.M in the office of Election Officer [Association Office]
  
- 4) Scrutiny of nominations & display of eligible candidates list : **23/2/2018, 6 P.M**
  
- 5).Last date of withdrawal of Nomination forms : **24/2/2018** from 3 P.M to 6 P.M
  
- 6).Display of Final List of Contesting Candidates after withdrawal : **26/2/2018** in the office of Association  
In case of not more than one candidate for any post, the candidate will be declared as elected unopposed.
  
- 7).Date & time of election (if required) : **12/3/2018** between **11 A.M to 5 P.M** at Association office, I.P.Bhawan, ITO, New Delhi - 110002
  
- 8).Counting of Votes & declaration of result: **13/3/2018** from 11 A.M


NOTES:

- 1). Members who have paid their subscription up to the year 2017-18 and are not in arrears, are eligible to contest (subject to **clause 32.04.6 to 32.04.9** of bye-laws), propose, second and to vote in the election.
- 2). No member would be permitted to contest for more than one post (**Clause No.32.04.3**)
- 3). Any member posted anywhere in India shall be eligible to contest for the post of GENERAL SECRETARY (Central). For other office bearers (Central) members posted only at Delhi/New Delhi shall be entitled to contest.(**Clause 32.04.4**). The details of other eligibility conditions shall be as per **Clause 32.04.6 to 32.04.9 of the bye laws of the Association**
- 4). Every member shall cast one vote for each post and voting shall be through secret ballots.
- 5). Members who can attend voting at New Delhi can cast their votes at Central venue. The other outside members (other than posted at New Delhi, Delhi, Ghaziabad, Noida, Faridabad, Gurgaon etc. of NCR) who cannot be present at Delhi to cast their votes shall be entitled to vote by Postal Ballot which will be sent by **Speed Post/Registered Post** on or before **01/03/2018** by the Election Officer. The same are to be sent back to the Election Officer by Speed Post/Registered post up to **5.00 P.M on 12/3/2018**.
- 6). Members posted outside the Region/Zone/Branch/Unit Headquarters are requested to contact their respective Region/Zone/Branch/Unit Office for further details.
- 7). Postal Ballot to be sent by speed post/registered post well in time. No complaints will be entertained regarding Non-Receipt of Ballot due to postal delay.
- 8). **For any kind of disputes arising in the process of election, decision of the election Officer shall be final and binding on all (Clause No.32.04.5).**
